

Resolution 06-016

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLAY COUNTY, GEORGIA TO AMEND THE CODE OF ORDINANCES OF CLAY COUNTY, GEORGIA; TO PROVIDE FOR A UNIFORM POLICY AND PROCEDURE FOR THE INSERTION OF ADDITIONAL ORDINANCES TO THE CODE; AND THE AMENDING OF EXISTING PROVISIONS TO THE CODE AND SUPPLEMENTING OF THE CODE; AND TO REPEAL PRIOR INCONSISTENT RESOLUTIONS; AND FOR OTHER PURPOSES

BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of Clay County, Georgia, in a meeting duly assembled, and it is hereby resolved by the authority of same to amend the Code of Ordinances of Clay County, Georgia as follows:

(a) By inserting therein the following:

**TITLE I: GENERAL PROVISIONS
CHAPTER 10.GENERAL PROVISIONS
§ 10.14 ORDINANCES WHICH AMEND OR SUPPLEMENT**

(C) All ordinances proposed, whether by addition to the Code or by amendment, shall be initiated by the Board of Commissioners as a resolution for the addition of a new ordinance or the amending of an existing ordinance. Such resolution shall provide a numerical number by the year and sequence of adoption.

(D) Resolutions proposed for amending or supplementing the Code maybe adopted at such time of presentation, provided the amendment or supplement contains no taxing provision or penalty of fine or incarceration provision nor amends an existing provision that provides for taxation or penalty.


(E) Resolutions proposed for amending or supplementing the Code containing provisions to impose a tax or criminal penalty by fine or incarceration or amend an existing provision providing for taxation or penalties shall be adopted upon the resolution presentation being made at a regular or called meeting of the Board as a first reading and initial approval for adoption, public notice of same being given by publication for two consecutive weeks in the legal organ of the county providing the date, place, and time of the consideration for final approval by the Board for implementation. Copies of the proposed resolution shall be filed with the County office and the Clerk of Superior Court upon its being first proposed.

(b) All ordinances and resolutions and parts of ordinances and resolutions in conflict hereof being hereby expressly repealed and amended hereby.


(c) That this Resolution shall become effective immediately upon its passage.
