

RESOLUTION 07-018

A RESOLUTION OF THE COUNTY OF CLAY COUNTY, GEORGIA, ADOPTING AN AD VALOREM MILLAGE RATE FOR CLAY COUNTY OPERATIONS AND MAINTENANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2007; ADOPTING AN AD VALOREM MILLAGE RATE FOR THE CLAY COUNTY SCHOOL BOARD OPERATIONS AND MAINTENANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2007; ADOPTING A MANDATED LEVY FOR STATE OPERATIONS; DIRECTING AND INSTRUCTING THE TAX COMMISSIONER TO MAKE OUT AND COLLECT THE SAID COUNTY TAXES AT THE SAID RATE; PUBLISHING AND POSTING SAID TAX LEVY AT THE COUNTY COURTHOUSE; AND ESTABLISHING AN EFFECTIVE DATE.

NOW THEREFORE, BE IT RESOLVED by the County Commission of Clay County, Georgia, as follows:

- 1. That 17.826 Mills, or \$1,560,843 hereby be levied county-wide, hereinafter provided and fixed as the rate of taxation for Clay County, proposed for the year 2007-2008, said levies to be for operation and maintenance of the County;
2. That 12.0 Mills, or \$1,000,324, hereby be levied within the incorporated and unincorporated areas of the County, hereinafter provided and fixed as the rate of taxation for the Clay County Board of Education, proposed for the year 2007-2008, said levies to be for the School Board;
3. That, in addition to the above assessments and levies, .25 Mills, or \$21,484, be hereby levied for the State of Georgia;
4. That the Tax Commissioner be hereby instructed and directed to make out and collect County Taxes and School Board Taxes for the said year at the said rates;
5. That the County Tax Levy be published and posted within the County Courthouse;
6. That this Resolution shall become effective immediately upon adoption.
